Environmental, Health and Safety (EHS) data is collected from all companies including forestry, paper, packaging, and wood products through a biennial survey as part of AF&PA members' commitment to uphold EHS principles. Data collected supports AF&PA advocacy work in a variety of policy arenas and demonstrates members' commitment to continuous improvements.
